TEN OF THOSE CONSULTATIONS RESULTED IN THE RELATIVE MOVING INTO THE HOME STUDY PROCESS, WHILE OTHERS PROVIDED ADDITIONAL SUPPORT TO THE YOUTH.

DURING FY21, WE CONTINUED TO DEEPEN OUR POST-PLACEMENT SUPPORTS BY EXPANDING THE BUDDY FAMILY PROGRAM AND CREATIVELY MODIFYING FAMILY RETREATS. MINNESOTA HEART GALLERY PROVIDED 83 YOUTH WITH PROFESSIONAL PHOTO SESSIONS. THE IMAGES ARE USED TO HELP RECRUIT A FAMILY, AND FOR THE YOUTH'S PERSONAL USE. WE STRENGTHENED THE MYVOICE PROGRAM AND PROVIDED OPPORTUNITIES FOR LEADERSHIP DEVELOPMENT AND ENGAGEMENT FOR 30
