Blazing a Trail

On the cover is a new family—Brian, Brandon and their son, Leo. Together, they've cleared away obstacles that were thrown in Leo's path during his many years as a ward of the state.

Leo, like most of the approximately 900 Minnesota youth who await adoption from foster care, had experienced incredible trauma and loss separation from his family as a toddler and multiple moves from foster home to foster home.

Brian and Brandon believe—like we do—that "every kid should have a home." Every year, Ampersand Families helps to blaze the trail for dozens of teens and families like Leo and his dads. Their stories are remarkable.

So, too, is the research on outcomes for adopted youth. In a study completed by Wilder Research in 2020, we learned that young adults who were served by Ampersand Families were healthier, more hopeful, and more often employed than were their peers who had aged out of "the system" without being restored to a family.

Building a new family is not easy—but our youth are worth the effort. Thankfully, many people are working together to break down barriers for resilient youth like Leo. We are especially grateful for the adoptive parents who make lifelong commitments. And we thank our exceptional staff, volunteers, and generous donors. We appreciate you all.

Thank you for helping struggling teens to become optimistic young adults. Together, we are clearing paths to brighter futures.

2020 Accomplishments

Ampersand Families is Minnesota's only nonprofit adoption agency focused exclusively on providing permanency services to teens and families who face the greatest barriers in the child welfare system. We help our community's oldest, longest-waiting youth to move from temporary foster care into permanent, loving families.

In FY2020, 88% of the youth we served were age 10 or older and about two-thirds were youth of color. We provided individualized family recruitment, proactive training and matching, comprehensive transition services, and innovative post-placement supports.

We can work with counties and tribes anywhere in the state. Last year, we:

- Helped 35 youth to join adoptive families
- Completed home studies for 25 families
- Supported 59 family members who sought to provide a permanent home for a relative child

We also:

- Strengthened post-placement supports, expanding our Buddy Family program and hosting in-person and then virtual family retreats
- Arranged free professional photo sessions for 70 children and sibling groups (www.minnesotaheartgallery.org)
- Built up the MYVoice leadership program for 25 older youth who experienced foster care



Leo had lived in the child welfare system for more than 10 years and didn't meet his new family until he was age 15. This year, he graduated from high school and is confident about his future.



Plus, in the last quarter of the year, in the face of COVID, escalated calls for racial justice and economic recession, we doubled down on delivering exceptional direct services. We:

- Adapted youth and family activities to creatively provide support in COVID-safe ways, like sending family wellness boxes in lieu of in-person retreats
- Helped families to support our youth, who are uniquely affected by the triple pandemics of COVID, systemic racism and fears about the impact of the recession on the people they love

Above all, we continued to take an anti-racist, familyaffirming approach to our work during this time that demands proactive, visible leadership.
