## **Above and Beyond**

We turned 15 last year! And like most 15-year-olds, we're growing and changing. We're excited to share highlights from FY24 in this report that demonstrate our expanded commitment to youth and family wellbeing.

Living in foster care is incredibly difficult. Kids in care consistently report feeling lonely, scared, confused, sad, and hopeless. Teens who age out of foster care without high levels of support face increased risk of social exclusion, poverty, homelessness, unemployment, incarceration, and poor mental health.

That's why we're going the extra mile to help kids and teens in foster care find family. Young people in care need and deserve people willing to go above and beyond to help them re-establish permanency and stability.

Whether it's finding and contacting 100+ relatives and kin as a potential placement or permanency resource for every child referred, recruiting an adoptive family whose skill sets match the complex needs of a child who's spent years waiting, or helping a teen who declines adoption instead build a network of trusted adults to support them, we listen to youth and we give it our all for each and every young person whose future we are entrusted with. In this report, you can read about some of the exceptional programs we're proud to offer that go above and beyond our core permanency and adoption services. These programs are helping youth and families build or rebuild family connections, grow their supportive networks, and gain valuable new skills.

Our robust roster of programs was developed over the last 15 years in response to the needs of youth and families and long-overdue changes in the child welfare sector. We're proud to be leaders and innovators in creating programming that doesn't just meet expectations but exceeds them.

Unlike other agencies, we keep the door open to youth and families to receive services and support for as long as needed, even years after an adoption has been finalized or a case closed. Because the work of healing doesn't really have an end date.

We're grateful to the Minnesota Department of Children, Youth and Families for funding a portion of this work. Additional financial support from foundations and individuals has been and continues to be critical to our capacity to go that extra mile to create hope and healing for kids in care and their families.

### **2024 AGENCY HIGHLIGHTS**

#### **STAYING CONNECTED TO RELATIVES AND KIN**

Kin Link and Relative Search & Engagement (RSES) are currently our fastest growing service areas. Through these services, we do an exhaustive search for family members for kids just entering the system as well as kids who have spent years in care and are at risk of aging out. What we see, time and again, is that when provided the opportunity, family takes care of family.

Last year, we helped 78 young people, age 0-17, maintain or rebuild their connections to family, community, and culture through Kin Link and RSES.

#### **CREATING FAMILY MEMORIES**

Families who welcome a child into their lives through adoption from foster care are courageous and wonderful. They can also feel isolated and overwhelmed by new and unexpected challenges.

Our Family Retreats provide a safe peer group environment for youth and adults that helps normalize the transitions adoptive families experience. Youth participate in fun activities like rock climbing, biking, bowling, sledding, crafts, and naturalist programs while adults connect and learn around issues like trauma and attachment-informed parenting, mindbody interventions, medication management, and special education. These no-cost, fun-filled weekends provide experiences many families would otherwise not be able to afford.

#### Last year, we hosted four family retreats at fun locations around the state attended by 100+ youth, caregivers and staff.

Caregivers who participated reported feeling more connected to other parents, more empowered in their role as parents, and more knowledgeable about the resources available to help them overcome barriers. Kids said they loved the activities and wanted more retreats.

#### ADDRESSING THE IMPACTS OF TRAUMA

Childhood trauma has impacts that can last a lifetime. Kids who have experienced abuse or neglect often have trouble regulating their emotions and developing secure attachments to others. This can interfere with socialization and education and create safety concerns for them and their families.

The Neurosequential Model of Therapeutics<sup>™</sup> (NMT<sup>™</sup>) is a groundbreaking assessment model developed by Dr. Bruce Perry that identifies the specific impact childhood trauma may have had on a child's brain development and provides actionable steps to heal neglected neural pathways.

Ampersand Families is the only agency in Minnesota offering no-cost NMT<sup>™</sup> assessments to young people ages 6–23 who have been impacted by the foster care and adoption systems. Families also receive stipends to fund recommended interventions such as a trampoline, drum set, swimming lessons, yoga classes, pet therapy, occupational therapy, and sensory activities.

Last year, we completed NMT assessments for 31 Minnesota kids and young adults. 100% of families surveyed indicated they would recommend the assessment to others.

#### **EXPANDING THE SUPPORT NETWORK**

An adoptive family's support network can get a lot smaller once their child moves home. People who said they would be there often fade away once a youth moves home and parents actually need help.

Our Buddy Family program was created in response to this difficult truth. Community volunteers are thoughtfully matched with an adoptive family and spend time with a youth at least twice each month, giving everyone a break from the demanding day-to-day work of building a family.

### Last year, we worked with 17 families to provide Buddy Family services to kinship and adoptive families.

This program continues to evolve to meet communithy and family needs.





### **2024 AGENCY HIGHLIGHTS**

#### **AMPLIFYING YOUTH VOICE**

Young people who have been in foster care have life experiences that are different from many of their same-age peers. They may find it hard to develop strong social bonds with young people who don't understand what they've gone through.

MYVoice is a program by and for youth ages 12–22 with lived experience in the foster care/adoption systems. Youth meet regularly for connection, education, and advocacy.

Last year, 124 youth participated in MYVoice activities including artmaking, book groups, panel presentations, and marching at the State Capitol for Foster Child and Youth Day on the Hill.

Unlike any other youth program in the state, MYVoice engages youth living in group homes, residential treatment centers, and juvenile detention centers. Ampersand Families was awarded a competitive grant from the MN Department of Public Safety in FY24 to deepen our reach into these restrictive settings.
